Donald M. Amundson, JD, is Senior Associate General Counsel in the University of Minnesota's Office of the General Counsel, which he joined in 1996. His legal practice focuses on international activities and agreements, in addition to general business matters. He works very closely with the University's Global Programs and Strategy Alliance as well as many other University units to help manage risk in connection with the University's international activities. He has been a frequent presenter on international risks and legal issues in higher education and also was a contributing author to a chapter on Legal

and Regulatory Considerations in International Research Collaborations in the book published in 2010 entitled International Research Collaborations: Much to be Gained, Many Ways to Get in Trouble.

He is an active member of the National Association of College and University Attorneys (NACUA), including serving on its Board of Directors from 2017-2020, and has also served on its Finance and Audit Committee for several years, including chairing its Investments Subcommittee. He has presented a NACUA seminar entitled Ambassadors Abroad: Due Diligence in Sending Students Overseas at a CLE Workshop in 2011, a NACUBO seminar on University Global Support Models at its 2013 Global Operations Forum, co-led a NACUA Annual Meeting discussion group entitled The Policy and Practice of Education Abroad: The Role of Counsel and other Stakeholders in 2014, a NACUA seminar called Going Global: Identifying and Managing Risks in Study Abroad in 2018, and presented several other webinars and seminars on international legal issues for higher education.




#### ANDREW COLLUM

Chancellor
University of Illinois at Urbana-Champaign



Robert J. Jones became chancellor of the University of Illinois at Urbana-Champaign on September 26, 2016. He previously served as president of the University at Albany, State University of New York (SUNY) and is an experienced and accomplished scientist and research university leader.

A Georgia native, Jones earned a bachelor's degree in agronomy from Fort Valley State College, a master's degree in crop physiology from the University of Georgia, and a doctorate in crop physiology from the University of Missouri, Columbia. He is a member of the American Academy of Arts and Sciences and is a fellow of the American Society of Agronomy and the Crop Science Society of America. He began his academic career as a faculty member at Minnesota in 1978 and became an internationally respected authority on plant physiology.

At the University of Illinois at Urbana-Champaign, Jones serves as chancellor of the state's flagship, land-grant university and vice president in the University of Illinois system, with universities in Chicago and Springfield. At Urbana, Jones' tenured faculty home is in the Department of Crop Sciences, College of Agricultural, Consumer and Environmental Sciences (ACES). Jones is the first African American scholar appointed as Urbana chancellor since the office was created in 1967.





#### ARTEMIS VELAHOS KOCH

Executive Director, Office of Global Support Services
Penn Global and Division of Finance, University of Pennsylvania

Artemis joined University of Pennsylvania in 2012 as the inaugural Executive Director of the Office of Global Support Services (GSS). Artemis leads the development and administration of a services delivery model supporting the University's international programs. She directs the GSS team and functional specialists throughout Penn to streamline business processes and establish cross-functional policies and best practices. Artemis earned a BS in business from Drexel University and a MT (Tax) from Villanova

University School of Law. She spent 15+ years in public accounting and consulting before joining Penn and is currently a candidate for a Master in Law degree from Penn Law.



**GIL LATZ**Vice Provost - Global Strategies
The Ohio State University



Gil Latz is vice provost for global strategies and international affairs and professor of geography, The Ohio State University. This appointment includes serving as President, The Ohio State University Global Gateway Network LLC Board of Advisors for Gateway Offices in Shanghai, Mumbai and Sao Paulo.

In his administrative role, Latz is broadly interested in internationalization, diversity, community engagement and global learning for all – and how these areas intersect – as well as the internationalization of higher education in the United States and Asia. His research career has focused on comparative study of regional development and resource management policy (rural and urban areas) in East Asia, North America and Europe. Currently, his research interests explore Japan's modernization process in terms of the role played by philanthropy and civic leadership.

Latz holds a BA (1974) from Occidental College, majoring in Religious Studies and English Literature. He earned his MA (1978) PhD (1985) degrees in geography from the University of Chicago. From 1980-84, he was a graduate research student at the University of Tokyo as part of his dissertation field work on 20th century agricultural development policy. In 2001-02, he was affiliated as a Fulbright research scholar at the University of Florence, studying the conservation of cultural landscapes. Latz's national leadership includes service as president, Association of International Education Administrators (2015-2017); senior associate for internationalization, American Council on Education (2016-); and US-Japan Bilateral Advisory Board US-Japan Higher Education Engagement Study (2019-21).





**REITUMETSE OBAKENG MABOKELA**Vice Provost International Affairs & Global Strategies
University of Illinois at Urbana-Champaign



Reitumetse Obakeng Mabokela is the Vice Provost for International Affairs and Global Strategy and Professor of Higher Education at the University of Illinois at Urbana-Champaign. She received her BA in Economics from Ohio Wesleyan University, magna cum laude and Phi Beta Kappa. She received a Master's in Labor & Industrial Relations and a Ph.D in Educational Policy Studies, both from the University of Illinois at Urbana-Champaign.

A former Fulbright New Century Scholar fellow, Prof. Mabokela's research seeks to understand experiences of marginalized populations and aims to inform and influence institutional policies that affect these groups within institutions of higher education. Her research centers or has centered on the examination of three interrelated themes: 1) organizational change and organizational culture in higher education; 2) gender in higher education; and 3) higher education in transitional societies. She has devoted a significant part of her career over the past two decades studying these education issues in South Africa, Namibia, Tanzania, Ghana, Egypt, and Pakistan among others. Over the course of her career, she has secured more than \$27 million in external funding to support various education and research initiatives.

She is the author, co-author, editor or co-editor of seven books and has published extensively in academic journals including Comparative Education Review, American Educational Research Journal, the Africa Education Review, and The Review of Higher Education, Comparative Education, Higher Education, among others.



MARTIN MCFARLANE
Director, International Student & Scholar Services

Martin became director of International Student and Scholar Services (ISSS) in 2015. A former international student himself, he had been with the ISSS office for ten years prior to becoming director, and held responsibility as the office's primary expert on student visa policies and regulations. Martin earned his Master's degree in English and Film Studies from the University of Aberdeen.





#### **KENNETH MUNROE**

Manager of Finance and Accounting, Education Abroad and Overseas Campuses, Temple University



Kenneth is the Finance and Accounting Manager for the Education Abroad Office at Temple University in Philadelphia, PA, where he's been since 2018. In addition to his budgetary and accounting responsibilities, he oversees student billing, departmental HR functions as well as strategic planning and process improvement initiatives. Prior to joining his alma mater, where he earned his MBA in Accounting, Kenneth held various finance and operations leadership roles at Penn Medicine for over 12 years.

Kenneth's passion for international education and cross-cultural collaboration stems from his first visit to Mexico as a community health volunteer while in high school. 


**BRAD STEPAN**Director of North American Operations
